Up to three credits-offered concurrently in three individual courses of one credit each-may be earned at the undergraduate or graduate level. Course 1

Course Title:	Trends and Practices in Music Education
Course Number:	MUCC 497 (1 undergraduate credit) or MUCC 597 (1 graduate credit)
Course Prerequisites:	None
Registration Deadline:	Monday, November 23, 2009, at 5 p.m. EST

Assignments Due:	Monday, November 30, 2009

Course Description: The purpose of this course is to provide students with the opportunity to attend a professional conference and experience and review a variety of performance and non-performance sessions.

Course Objectives: Students will attend and evaluate sessions presented by leaders in the field of music education. Graduate students will also describe how the sessions relate to the practice of music teaching.

Course Requirements:

Undergraduate credit:

- Students registering for undergraduate credit are required to attend a minimum of fifteen (15) clock hours of events such as sessions, clinics, rehearsals, lectures, professional meetings, or concerts.
- Students submit a log showing the date, time, location, title, name of the presenter, panelists, or performers for each event.
- Students must obtain a signature from the presenter, presider, or performer at each session.

Graduate credit:

- Students registering for graduate credit are required to attend a minimum of fifteen (15) clock hours of events such as sessions, clinics, rehearsals, lectures, professional meetings, or concerts.
- Students submit a log showing the date, time, location, title, name of the presenter, panelists, or performers for each event.
- Students must obtain a signature from the presenter, presider, or performer at each session.
- Students submit a reflective assessment paragraph about each session, clinic, rehearsal, lecture, professional meeting, or concert regarding the application of the information presented/observed to teaching. (Note: Students who are not currently teaching should reflect on their perceived application of the information presented/observed to teaching.)

Course 2

Course Title:	Readings in Music Education
Course Number:	MUCC 498 (1 undergraduate credit) or MUCC 598 (1 graduate credit)
Course Prerequisites:	Concurrent enrollment in MUCC 497 (undergraduate students) or MUCC 597 (graduate students)
Registration Deadline:	Monday, November 23, 2009, at 5 p.m. EST

Assignments Due:	Monday, December 14, 2009

Course Description: This course consists of analytical reading of current articles from professional journals, book chapters or similar materials related to effective teaching.

Course Objectives: This course will expand the student's knowledge of current practices in the field, with opportunity to compare/contrast writings discussing best practice information.

Course Requirements:**Undergraduate credit:**

Students registering for undergraduate credit will read and submit complete bibliographic information plus content annotations and analytical comments for 10 (ten) articles.

Graduate credit:

Students registering for graduate credit will read and submit complete bibliographic information plus content annotations and analytical comments for 15 (fifteen) articles.

Course Title:	Best Practices Document
Course Number:	MUCC 499 (1 undergraduate credit) or MUCC 599 (1 graduate credit)
Course Prerequisites:	Concurrent enrollment in MUCC 497 and 498 (undergraduate students) or MUCC 597 and 598 (graduate students)

Course Description: The purpose of this course is to provide students with the opportunity explore in depth one topic related to exemplary practices currently employed in teaching.

Course Objectives: Students will prepare a formal paper, with citations and bibliography, related to one aspect of best practices in teaching.

Course Requirements:

Undergraduate credit:

Students registering for undergraduate credit will prepare a clear and concise document with minimum length of 10 (ten) pages. See technical details below.

Graduate credit:

Students registering for graduate credit will prepare a clear and concise document with minimum length of 15 (fifteen) pages. See technical details below.

Technical Considerations

Preparing assignments:

- All written work must be submitted in typewritten, double-spaced text with 1-inch margins.
- Consistency in style is expected in documentation, references, citations or annotation of sources. The American Psychological Association (APA) Manual of Style (5th Edition) is the preferred format.
- Each topic should begin on a separate page identified with appropriate headers. The name of the student should appear on each assignment
- Materials submitted are not returned.

Submitting assignments:

Mail materials for each course as a single unit (spiral, termpaper, or notebook binder to the instructor.
