



## Healthcare Management Graduate Certificate

A hybrid, part-time, two-semester professional certificate (12 credits)

### PROGRAM DESCRIPTION

The Healthcare Management Graduate Certificate at Shenandoah allows you to understand the dynamics and complexities of the healthcare industry and to deliver impactful results. The certificate prepares you to identify, anticipate, analyze, and solve complex problems in healthcare.

Healthcare employment opportunities are growing fast, with excellent prospects for applicants with leadership skills in business and management. Changes in healthcare regulations, implementation of new technologies and emphasis on preventative care contribute to increased need for healthcare management specialists.

### PROGRAM PREREQUISITES

- Bachelor's degree from a regionally accredited institution – all majors welcome.

- Resume/C.V.

### CURRICULUM

The certificate consists of four hybrid courses, or 12 total credits, offered either in flex-format or on campus in Winchester, Virginia. The full program can be completed in two semesters.
