MISCCWLET013	Letter from Charles Bartlett, 12 th Massachusetts Infantry, from Charles Town, VA, March 8, 1862. Letter contains descriptions of Charles Town, notes about sentiment, Harpers Ferry-related content too.

MISCCWLET014 Letter from Samuel Hall, 34th Massachusetts Infantry, from Harpers Ferry August 18, 1864. Letter contains references to bushwhackers, perspectives on soldier life, looking forward to end of enlistment, and storage of government stores. MISCCWLET015 Letter from Mann Page, 21st Virginia Infantry, from Winchester, VA, February 22, 1862. References to Romney Campaign, condition of Confederate camps around Winchester, weather, health, thoughts on English and French intervention, encouragement to family members to not let defeats discourage his uncle. MISCCWLET021 John S. Root, 20 th Connecticut Infantry, to Sister Helen, October 15, 1862, Camp Near Harpers Ferry, at the base of Maryland Heights. Content about camp, troop movements, Genl. Banks.
MISCCWLET022 Unidentified soldier in Banks' command, April 26, 1862, Camp near Keezletown, VA. Rockingham rebellion, living conditions, environmental conditions, pursuit of Confederates
MISCCWLET023 Letter of Marion White, 3 rd Wisconsin Infantry, to cousin, May 14, 1862, from Strasburg, VA. Discusses Banks' fort, beauty of Valley.
MISCCWLET024 Letter from Henry A. Laselle, 114 th NY Infantry, to Mr. H. Seymour, March 15, 1865, from Camp Sheridan [Winchester], VA. Perspectives on patriotism and support for the Union war effort, review by General William H. Emory, General Hancock, arrival of Confederate POW's captured at Waynesboro.
MISCCWLET025 Letter from Private Benjamin F. Weeks, 214 th Pennsylvania Volunteer

	Infantry to wife, May 9, 1865, Summit Point. Letter discusses camp, review by General Thoburn of Army of the Shenandoah, health conditions, and quality of regiment. File also contains biographical information and other ephemera associated with Weeks.
MISCCWLET026	Letter from William Davis Ewing, 52 nd Virginia Infantry, June 24, 1863, to wife, from Winchester, VA. Letter discusses medical conditions, Jordan Springs, treatment of civilians, and medical service.
MISCCWLET027	Letter from James Stapleton, 111 th Pennsylvania Volunteer Infantry and 22 nd Veterans Reserve Corps, October 20, 1864, Indianapolis, IN. Letter offers perspectives about Sherman's capture of Atlanta and Sheridan's successes in the Shenandoah Valley, and perspectives about God being on the side of the Union.
MISCCWLET028	Letter from George Brown, 9 th New Hampshire, to Mr. Towle, December 29, 1862, General Hospital Harpers Ferry. Letter addresses items related to Brown's service as head nurse as hospital, Battle of Antietam, mood of the army, hatred of Emancipation Proclamation, and President Abraham Lincoln. Also contains original cover address to Mr. William Towle, esq. and postmarked from Harpers Ferry, December 30, 1862.
MISCCWLET029	Letter from Judge Richard Parker (one who presided over John Brown's trial) to father Judge Richard Parker at the Retreat. Letter is dated February 22, 1836, and discusses life as an attorney, Martin Van Buren, and desire to visit the Retreat.
MISCCWLET030	Letter from Stephen Richardson, 24 th Veteran Reserve Corps (originally served in 108 th New York), to Private Seth Wells, 108 th New York. Letter written from Wisewell Barracks, Washington, DC. Letter offers commentary on the upcoming 1864 presidential election and General Philip H. Sheridan's victory in the Shenandoah Valley.
MISCCWLET031	Letter from Lewis Foster, 9 th NYHA, February 19, 1865, to mother. Letter discusses soldier life, weather, price of goods, family relations. Note that this letter does not appear in "A Good Cause": Letters from the Ninth New York Heavy Artillery. Also includes cover.
MISCCWLET032	Letter from Sgt. Major Miles St. John, 48 th New York Infantry, to "Friend Mary," September 21, 1864, from "Near Petersburg, VA." Letter discusses action fighting and casualties in regiment, salute to Sheridan for his victory at the Third Battle of Winchester, promotion to sergeant major, and condition of the regiment.
MISCCWLET033	Letter from Corporal Quincy A. Randalls, 21st Ohio Infantry, to "Mr. Dunn Sir," September 28, 1864, from Atlanta, GA. Letter mentions Battle of Jonesboro and discusses reaction to news from Army of the Potomac and Sheridan's victories in the Shenandoah Valley, copperheads, support for George McClellan in the upcoming presidential election, and thoughts about war nearing its end.
