# **Introduction**

This Admission Guidelines document is designed to provide both the potential and matriculated student with information about the educational program leading to a Master of Science in Physician Assistant (PA) Studies. It should be viewed as an adjunct to Shenandoah University's **Graduate Catalog** which contains specific information regarding the university and related policies.

The information herein is subject to periodic revision, and these changes will be relayed to students in a timely manner. It is ultimately the student's responsibility to be aware of all degree requirements and to work closely with a faculty advisor to ensure these requirements are fulfilled.

## Overview of the Profession and Program

PAs are medical professionals who diagnose illness, develop and manage treatment plans, prescribe medications, and often serve as a patient's principal healthcare provider. With thousands of hours of medical training, PAs are versatile and collaborative. PAs exercise autonomy in decision-making and provide a wide range of diagnostic and therapeutic services including prescribing medication. The role of the PA includes provision of primary and specialty care in medical and surgical practices located in a variety of settings and geographic locations. PAs practice in every state and in every medical setting and specialty, improving healthcare access and quality.

The Shenandoah University Physician Assistant (SUPA) program is a graduate entry-level professional course of study enabling individuals who hold baccalaureate degrees to become PAs. The program is designed to prepare graduates for practice and the team approach to the delivery of healthcare. The program integrates graduate-level critical thinking and analysis, problem solving, scientific inquiry, self-directed learning and the effective use of modern technology for professional practice that includes elements of research, leadership, education and continued enhancement of the PA profession.

#### **Purpose and Goals**

The purpose of the PA program is to graduate competent professionals who are well prepared for the demands of modern professional practice in a rapidly changing health-care environment. The curriculum goals are based upon the <a href="AAPA/PAEA/NCCPA/ARC-PA">AAPA/PAEA/NCCPA/ARC-PA</a> "Competencies for the Physician Assistant" document, standards for educational programs contained in the "Accreditation Standards for Physician Assistant Education," the Program's Mission Statement, and the needs of the PA profession. In the PA program curriculum, knowledge, skills and attitudes are considered to be critical elements of professional practice and are addressed in the following curricular goals.

The program has three large overarching goals:

- 1. Maintain first time pass rate on PANCE above the national average.
- 2. Seventy-five percent of graduates will have permanent employment within twelve months of graduation.
- 3. The percentage of new graduates who practice in primary care will be above the national average.

# **Curriculum Design**

The curriculum design, offered in didactic and experiential components, is based upon the concepts of adult-centered learning and professional education, which focus on mastery of knowledge, skills and attitudes required by the graduate to practice effectively as a PA. The didactic curriculum offers multiple modalities for learning, which include self-directed study, recitation, lecture, integrated clinical cases and laboratory experiences. These modalities assist students in developing the necessary skills to be self-directed life-long learners and effectively apply what they learn in the clinical setting. The clinical curriculum provides core primary care and other learning experiences where students apply knowledge and skills in a variety of patient care settings under the supervision and mentoring of licensed health care providers.

# **Program Delivery Model**

The Shenandoah University PA program is offered on a full-time, in-person basis at two sites, Winchester and Loudoun. The length of the program is eight semesters (30 months). The delivery model is designed to prepare students for a rapidly changing healthcare environment where simple memorization of facts and figures is insufficient for effective clinical practice. Delivery of content includes face-to-face, asynchronous online, and video-teleconferencing. Learning is accomplished through a combination of independent study and preparation, lecture and discussions, small-group case-based exercises, and practical application. Interprofessional learning opportunities are integrated throughout the curriculum. The program as a whole is delivered in person, and students are expected to be available to attend all courses in person at their designated location. As adult learners, it is expected that students will actively engage in independent study, inquiry and clinical rotations outside the classroom to augment learning and to maximize effectiveness of classroom and laboratory contact time.

Since the SUPA program uses computer technology in the delivery of the curriculum, all PA students must be computer literate. The Shenandoah University PA program uses a technology program, which provides a laptop computer, an iPad, and technology support to each student. Participation in this program is mandatory.

Students are expected to adjust their non-curricular demands in order to complete the degree requirements. Employment is not recommended while attending the Shenandoah University PA program.

#### **Early Assurance Program**

High school students interested in applying to Shenandoah's Early Assurance Program should review the information and requirements provided online at the Physician Assistant Early Assurance Pathway site. Early Assurance applicants to the PA program require a completed and verified application to be submitted by June 25<sup>th</sup>, the year before matriculation into the Program to be included in the first round of interviews.

#### **Shenandoah University (SU) Articulation Agreement**

An <u>Articulation Agreement</u> between SU's undergraduate College of Arts and Sciences (CAS) and our graduate School of Health Professions (SHP) provides a pathway to the Master of Science in Physician Assistant Studies for applicants who are enrolled as full-time students at Shenandoah University for undergraduate study and will be obtaining a baccalaureate from Shenandoah University. This agreement is available to all currently enrolled full-time Shenandoah University undergraduate students who have not yet received a baccalaureate by the time of application. A reserved number of seats is set aside for those students who meet all the same admission requirements as regular applicants. **Articulation Agreement applicants to the PA program require a completed and verified application to the program to be submitted by June 25<sup>th</sup>, the year before matriculation to be included in the first round of interviews.** 

## **Admission Requirements**

- 1) To be considered for the Physician Assistant program, applicants must submit all application materials to the Central Application Service for Physician Assistants (<u>CASPA</u>) at <a href="https://caspa.liaisoncas.com/">https://caspa.liaisoncas.com/</a> including official transcripts from ALL institutions of higher education attended.
- 2) Preference will be given to:
  - a) Candidates who can demonstrate an alignment with the core values of the program. This alignment is assessed in the SUPA admission process including review of application and interview.
  - b) Candidates with higher GPAs. Although the minimum GPA threshold for application is 3.0 for cumulative undergraduate GPA, overall science and prerequisite GPA, candidates will be more competitive the higher the GPA.
  - c) Candidates with highly effective communication skills such as candidate poise, eye contact, articulation, clear train of thought, perceived comfort level, appropriate dress, and manners
- 3) The application also includes a supplemental essay to address this alignment directly. Candidates will be asked to choose three of the Shenandoah University PA Program's Core Values and, in a total of 500 words or less, explain how they have demonstrated those three core values in action.

Note: Healthcare experience is strongly recommended to develop a robust understanding of the PA profession and current healthcare landscape, however, healthcare experience, patient care experience and PA shadowing are not required for admission.

#### **Academic Requirements**

To be considered for regular admission, applicants must have:

- a. A Baccalaureate degree from an accredited institution is required to be completed prior to matriculation to the program. Applicants from all academic disciplines are welcome to apply, provided they meet the prerequisite course requirements.
- Submit all application materials to the Central Application Service for Physician Assistants (CASPA) at <a href="https://caspa.liaisoncas.com/">https://caspa.liaisoncas.com/</a> including official transcripts for all institutions of higher education attended and three recommendations.
- c. Minimum 3.0 cumulative undergraduate, overall science, and SUPA Program prerequisite Grade Point Averages (GPAs).
- d. GPA requirements are assessed <u>at the time of application</u> for review; any outstanding coursework that is not included in GPA upon application will be reviewed before matriculation. If a GPA falls below the minimum after application and before matriculation, a seat offer will be revoked.

An applicant with a cumulative undergraduate or overall science GPA less than 3.0 but greater than 2.80 and who has completed a minimum of 15 semester hours of relevant graduate work with a 3.0 or better GPA, may be considered. See FAQs posted on the SUPA website for the definition of relevant graduate work.

Note: Average GPAs for students admitted to the SUPA Program have been over 3.5 for the past several years.

Applicants must complete the following prerequisite coursework (documented via official transcripts)

## **Required Prerequisites**

### **Recommended Coursework**

The courses below are *recommended* to better prepare for the Shenandoah University Physician Assistant curriculum; they are not evaluated to determine competitiveness of an application:

## **Important Notes**

- A grade of "C" or above is required for all prerequisite courses, however, it is strongly recommended that prerequisites be completed with a grade of A or B. Grades of "C-" or below are not accepted for prerequisite courses.
- No more than <u>TWO</u> prerequisites can be outstanding at the time of application.
- It is recommended that all prerequisite coursework be completed within 5 years of matriculation; the program will not accept any prerequisite coursework taken 10 years before the time of matriculation.
- The program requires that Human Anatomy & Physiology courses are taken at the same institution. If they are not, an additional audit and internal review will be required after application submission to ensure comprehensive coverage of topics. Human Anatomy and Human Physiology may be completed as two individual courses or by taking a combined Human Anatomy & Physiology I and Human Anatomy & Physiology II course sequence over two terms.
  - Comparative anatomy, mammalian anatomy, vertebrate anatomy, functional anatomy, animal physiology, anatomy and physiology designed for specific disciplines, or fundamentals of anatomy and physiology courses are not counted toward the A&P requirement.
- Prerequisites must be completed at a college or university in the United States. Courses completed at Canadian institutions will be evaluated on an individual basis.
- It is recommended that prerequisite coursework be taken in-person, however online coursework is accepted.
- Neither Advanced Placement credit (AP), International Baccalaureate (IB), or College-Level Examination Program (CLEP) credits are accepted to fulfill the prerequisite course requirements. For students who have received advanced placement (AP) credits for AP Psychology, a course in one of the following is required: Developmental Psychology, Child Psychology, Abnormal Psychology as these subjects will have the most relevance to the program curriculum.
- The program will accept "P" or related grades as satisfying any of the program's academic prerequisites for courses taken during the following COVID-impacted timeframe: Spring Semester 2020 Spring Semester 2021. Grades reported as Failing (F) or as Incomplete (I) will not be considered as fulfilling prerequisites.
- In some cases, work experience specific to the science course older than 10 years may substitute for repeating the course. Upload a formal request, a supervisor letter, and a resume to

- your CASPA application for review. We are unable to review these requests in advance of application to SU.
- A medical terminology proficiency exam will be administered during summer orientation. Failure to meet the minimum benchmark will require a formal remediation plan to be completed during the first summer semester.
- The program does not offer academic credit for experiential learning/work experience.

All applicants are asked to read and adhere to the <u>CASPA Admissions Code of Cooperation</u> available on the CASPA website.

# **Application Process & Timeline**

The SUPA Program processes an individual's verified CASPA application once it is received and considered **complete** by the program. An applicant's file must meet the following requirements:

- 1. All three references must be received by CASPA and must meet the following criteria:
  - a. One from an academic source (e.g. professor, academic advisor)
  - b. One from an employer/supervisor
  - c. The third reference may be any source that can speak to the applicant's suitability for the profession.
- 2. Plan for completing any outstanding prerequisites is documented in the "planned" section at the bottom part of the CASPA electronic transcript to include term, institute name, and course details. Outstanding prerequisite courses must be documented in this section for the application to be processed.

## **International Students**

- 1. Prerequisites must be completed at a college or university in the United States.
- 2. Applicants must submit an independent course-by-course evaluation from an approved evaluation company such as the World Education Services (<a href="www.wes.org">www.wes.org</a>) for foreign transcripts. If you have studied outside the US, you will need to have your transcripts evaluated for US equivalency using a service such as www.wes.org or www.ece.org. Follow CASPA's instructions to determine how to report coursework completed through study abroad. The program will add this coursework to your CASPA-calculated GPA to attain your cumulative undergraduate GPA, overall science, and prerequisite GPAs.
- 3. All applicants must demonstrate English language proficiency. Please <u>review our language</u> <u>proficiency policy</u> to determine if your educational background fulfills the requirement. Acceptable sources of proof are:
  - Completion of high school diploma from regionally-accredited U.S. institutions and approved countries.
  - Completion of post-secondary degree with GPA 2.5 or higher from regionally-accredited U.S. institutions and approved countries.
  - Completion of equivalent of Shenandoah University's ENG 101 with B or better at a regionallyaccredited U.S. institution.
  - If you do not meet the above requirements, you will need to provide proof of proficiency via submission of one of the following test scores:
    - o TOEFL (83 or higher)
    - o IELTS (6.5 or higher)

- Duolingo English Test (105 or higher)
- o Pearson Test of English (53 or higher
- Cambridge English B2 First, C1 Advanced or C2 Proficiency Exam (176 or higher)

Note: Please refer to SU's Evidence of English Language Proficiency policy.

## **Application Review**

The application review will include evaluation of the following to estimate the candidate's aptitude and preparation for graduate studies in alignment with SUPA core values.

- 1. Cumulative undergraduate grade point average (GPA) as calculated by CASPA
- 2. Overall science GPA as calculated by CASPA (includes undergraduate and graduate science courses)
- 3. SUPA Program Prerequisite GPA
- 4. Number of outstanding prerequisites and proper documentation of plan for completion
- 5. References
- 6. Narrative and supplemental essays submitted via CASPA

Note: It is the applicant's responsibility to check CASPA and our current website to make sure all requirements and documents are received in a timely manner in order to meet SUPA's deadline.

#### **Interviews**

After application review, the candidates selected are invited to participate in an interview to assess alignment with SUPA's core values. This interview also provides an opportunity to determine if the SUPA program is the best fit for the candidate's graduate studies.

There are sixty seats available in the program each year. In order to increase chances of acceptance, early application is strongly encouraged. Candidates are not permitted to select their interview date.

Mandatory orientation for the Class of 2027 will take place in person June 2025 before the start of the first summer semester at a date communicated upon seat offer.

## Rolling admissions timeline

Applications are accepted upon the opening of CASPA in April until September 1. Applications are reviewed upon receipt on a rolling basis throughout the cycle. An equal number of interviews are offered with each interview and an equal number of seats are offered after each interview, however because of the rolling nature, the pool of qualified applications increases as the cycle progresses. Candidates who are not offered interviews for interview #1 are placed back in the pool for interview #2 selection. Candidates who are not offered an interview in #2 are placed back in the pool for selection for interview #3. Candidates who are not offered a seat after interview #1 who are placed on the alternate list are considered for a seat along with those from interview #2. Candidates who are not offered a seat after interview #2 who are placed on the alternate list are considered for a seat along with candidates from interview #3.

## **Admission Decisions**

The program requires a non-refundable \$500 advanced enrollment deposit to secure seat placement, which is applied toward the first semester's tuition payment. Decisions are communicate to applicants via submitted emails in CASPA within 30 days of interview.

The admissions committee will recommend one of the following decisions based upon the program internal scoring model:

- a. <u>Full Admission</u>: Offered to candidates with all prerequisites complete along with a conferred bachelor's degree. Those with outstanding requirements will be recommended for provisional admission status.
- b. **Provisional Admission**: Candidates with a bachelor's degree and/or prerequisite courses "in progress" may be admitted as long as these requirements are fulfilled and official documentation received no later than by May 31st or the candidate's admission offer will be withdrawn.
- c. <u>Alternate Status</u>: Applicants selected as alternate candidates will be notified of their final admission status by mid-June. Those not admitted from the list must reapply if they wish to be considered in a subsequent cycle. Rank or position on the list will not be disclosed to candidates due to its dynamic nature (See FAQs).
- Denial: Applicants not selected for admission status will be notified.

## **Advanced Placement & Transfer Credits**

The program does not offer Advanced Placement. The program will not transfer credits into the program from another PA program.

#### Physician Assistant Studies/Master of Public Health (PA/MPH) Program

SU PA students have the option to apply for the Master of Public Health program in the first Spring semester in the PA program. ## **Credit for Experiential Learning**

The program does not offer academic credit for experiential learning/work experience

## **Technical Standards**

<u>Technical standards</u> for admission establish the expectations and abilities considered essential for students admitted to the program in order to achieve the level of competency required for graduation and clinical practice. Candidates should review these standards before initiating an application.

# **Deferment Policy**

The SUPA program does not honor requests for deferment of admission during the period between formal acceptance and matriculation except in extreme circumstances that are determined on an individual basis.

# **Other Requirements**

Applicants admitted to the program must provide evidence of good health and up-to-date immunizations prior to matriculation. Prior to beginning coursework, students are required to authorize and submit to a criminal background check, including sex offenses and crimes against minors. A history of a conviction at the felony level may prevent the student from placement for clinical training and thereby ability to satisfy graduation requirements. Students must also submit to drug testing required by clinical practice sites or the program. Non-compliance with the criminal background checks and/or drug testing policies may be cause for dismissal from the program. In addition, students are required to maintain health insurance and liability insurance coverage. Further information will be reviewed in detail at orientation. Admitted students are required to attend all orientation sessions scheduled by the program.

Falsification of any portion of the application process, including the CASPA application, will be cause for immediate withdrawal of the admission offer or dismissal from the PA Program.

# **Program Administration and Support**

## **Accreditation Status & NCCPA Pass Rate**

The Physician Assistant program is accredited by the Accreditation Review Commission on Education for the Physician Assistant, Inc. (ARC-PA). Graduates of accredited programs are eligible to take the national certifying examination offered by the National Commission on Certification of Physician Assistants (NCCPA). Most states require certification in order to practice.

As of January 24, 2024, the aggregate five-year first-time taker pass rate of Shenandoah University Physician Assistant program graduates (Classes 2019–2023) is 93 percent while the national pass rate for the past five years is 93 percent. Additional information regarding SUPA Program's graduate performance on the national certification (PANCE) examination is found on our <u>Accreditation & Outcomes</u> website page.

#### **Non-Discrimination Policy**

## **Cost & Financial Aid**

Tuition and fees are set annually. It is estimated that tuition, fees, and other program-related expenses for the program will total around \$102,344. This amount includes books (including e-texts), medical equipment, software, and supplies. Additional details are provided on the program website under the "costs and financial"

<u>aid</u>" tab. This cost does not include additional responsibilities for living expenses, travel to and from clinical rotations, and costs associated with temporary housing while on assigned clinical rotations.

Note: The Shenandoah University Board of Trustees reviews and approves the university budget on an annual basis. This document includes the most up to date figures at the time of publication. Tuition increases may be implemented.

Financial aid for graduate students is available primarily through student loans and private sources. Virginia residents may be eligible for the Virginia Tuition Assistance Grant (VTAG).

Through the generosity of alumni, community friends and foundations, the SUPA program is able to provide several scholarships each year. Additional information regarding SU as well as private and professional association scholarships will be provided in fall of entering year.
